- II. Two Reading Course Items, First Reading (To be implemented Fall 2020 pending local approval and CCCCCO chaptering)

A) NRN

**The numbers of these courses will need to be changed. We will need 4 groups of unused numbers, one for each semester.**

**All courses except NRN 64 are proposed for Hybrid only. NRN 64 is proposed as eligible for DE.**

**Most courses are lecture and lab combination. Disciplines are both Masters and non-Masters level in many of the courses. NRN 64 and NRN 82 are placed in Masters level Nursing discipline.**

**Prerequisites are set for the main courses in 2<sup>nd</sup> semester and beyond: 51 for 61, 61 for 71, 71 for 81. Courses will only be scheduled for the cohort model that nursing uses. Corequisites are not necessary for this purpose.**

**Discussion about the large amount of content and objectives for courses of 1 or 1.5 units. The reason for this is the integration of content throughout the semester and the spiraling of course objectives that are similar but at a higher level each semester. Also discussion about the courses with large number of units (7 and 8 unit courses). This is a big impact on a student's GPA if they don't pass the course, but less of a scheduling issue for students needing to retake course due to failing.**

**The committee also discussed the lack of fulltime load each semester and the impact on financial aid and the equity issue that poses. There are a few GE courses that students can take concurrently with the program. There are also some UC transfer requirements that a student might take. Finally, the department stated the goal of students beginning baccalaureate level nursing courses at CSUMB or SJSU or an online program while finishing the final semesters of the AA degree. Financial aid issues can occur with that system as well. Financial aid eligibility is usually determined by one college and not courses at two institutions. Hartnell has capacity challenges in monitoring financial aid eligibility when students are getting financial aid from the 4-year college.**
