INFORMATION/DISCUSSION/PRESENTATIONS

- 1. Discussion with Jay Singh on Disaggregated Data for Disproportionately Impacted Students
 - Jay introduced himself to the group and provided a little background on his role as the Director of Academic Affairs for Student Academic Support. Guy presented his list from the previous meeting that contained student factors identified by the Chancellor's Office for disaggregating data. While the list was quite varied, Guy indicated that there are three that are absolutely required from the ACCJC. They are:
 - Age
 - **Ethnicity**
 - Gender

Other student factors on the list include:

- Foster youth

Some additional factors that other institutions are tracking for students also include:

- Prior learning credit
- Working
- Declared

Within these student factors, there are institutional factors that can be examined in terms of that data such as:

- Delivery method
- Term type
- Time scheduled
- Service location
- Type of curriculum (accelerated vs. non)
- Support services used by students

Guy mentioned that all of the items in the Student Factor list are reported in our Equity Plan data and it would be nice for us to be able to have learning outcome data that aligns with the things we already report on. Guy stated that Jay is instrumental with the college's equity plan and also reports the NOVA data. Jay explained that if a college receives student equity funding then they must report out data on identified groups of students who are disproportionately impacted. An example that Jay gave the committee members is data that has been reported out on male Veterans and retention. The college tracks if those students persist from fall to spring. We look at the various ways that we are supporting those male veteran students such as learning resources, the Veterans Center activities, support with registration, financial aid, etc.

Cheryl asked Jay if he would recommend that the O & A committee reach out to other committees that deal with equity and diversity and ask them to identify attributes that they might want to see pulled into the data load for eLumen. He supported that idea.
