# INFORMATION/DISCUSSION/PRESENTATIONS

1. Value Rubric Project: Discussion and presentations continued on the Value Rubric project.

**Global Engagement CC**: The Global Engagement team presented the work that had been continued on their rubric. Capstone criteria for the three categories (Knowledge, Skills, and Attitudes) has been completed. Remaining criteria for columns 3, 2, and 1 need to be reviewed. Discussion occurred about the perspective that is used to view cultural rules and biases. Should it be from the individual's perspective or that of the culture itself. Wording in column 3 of the Knowledge category was changed to be

parallel with that used in column 4, "perspectives about own and other cultural rules and biases." Discussion also focused on if there needs to be a separation or delineation in each category for assessment purposes to indicate if learning had occurred for one of the two sub-categories but not the other. Could possibly indicate this in the N/A column. When this rubric is taken as far as the committee feels it can, it will be given to instructors who teach courses that were placed by the GE sub-committee into the Global Engagement CC. Guy and Cheryl will identify these instructors and send for review.

**Inquiry and Reasoning CC**: There are three value rubrics that align with this CC:

- Problem solving
- Inquiry and Analysis
- Critical Thinking

Dan likes the critical thinking rubric the best. Toni commented that we need to add problem solving category to that rubric to address the variety of courses in the math and science areas that incorporate problem solving.

#### Communication CC:

**Written communication**: Dan presented some additional language that he suggested to be added to the written communication rubric. The additional row was to add a category for documentation of sources, which he stated was vital to what we do in academic writing. The question was brought up as to what terminology should be used to refer to the bibliography. In the previous meeting Dr. Matsunaga provided a report from CSULA that contained a rubric. Dan will work with Dr. Matsunaga to review her rubric with the value rubric that he modified.

**Oral communication**: Cheryl will share the value rubric with Jason Hough and Daniel Lopez for their review and input.

Target date for completing the rubric project is September 28.
